

# Macarthur Square Ice Skate Lane - Terms and Conditions

## Terms and Conditions

1. The Promoter is Macarthur Square Shopping Centre of Level 14, Tower Three, International Towers Sydney, Exchange Place, 300 Barangaroo Avenue, Barangaroo, NSW, Sydney 2000 (**Lendlease**). Contact number is (02) 4626 1466.
2. Only residents of Australia aged 18 years of age or older (**Participant**) are eligible for the promotion. Participants under 18 years of age must obtain the prior permission of a parent or guardian over the age of 18 years to enter the promotion, evidenced by the parent or guardian completing the entry form.
3. The following person(s) are ineligible to enter the Competition:
  1. employees of:
    - The Promoter
  2. the Promoter's related bodies corporate (as that expression is defined in the Corporations Act 2001 (Cth), and associated agencies, companies and contractors; or
  3. members of the Immediate Families of the employees referred to at paragraph below.

**Immediate family** means any of a spouse or domestic partner, ex-spouse or ex-domestic partner, de-facto spouse or ex-de-facto spouse, child, or stepchild (whether natural or by adoption), parent, stepparent, grandparent, step grandparent, uncle, aunt, niece, nephew, brother, sister, stepbrother, stepsister or first cousin.

4. Ice Skate Lane commences between Tuesday 2 to Sunday 21 July, from 11am – 3pm.
5. Ice Skate Rink Rules include: Skaters must have a shoe size of greater than child size 9, Skaters must provide their own pair of socks, Children must not be left unattended, No food or drinks allowed on the rink, Skates only allowed on rink, Parents and spectators must stay outside of fenced area, No games or racing allowed on rink, We accept no liability for injury or damage to skaters on the rink, Skate with arms out, Keep head up and eyes forward, knees bent, Pick up each foot to move forward, Turn feet out, in a V-position, Pick up each foot to move forward, Skate at a moderate and controllable speed, Skaters should not lay on the ground and should get up quickly after a fall.
6. The Promoter accepts no responsibility for lost, stolen, misplaced or injury caused on the ice rink.
7. Nothing in these terms and conditions is intended to exclude, restrict or modify rights which the Participant may have under any law (including the Australian Consumer Law) which may not be excluded, restricted or modified by agreement ('Your Consumer Rights'). Subject to Your Consumer Rights, the Promoter is not liable for any loss or damage however caused (including by negligence), suffered or incurred in connection with Ice Skate Lane. Any condition or warranty which would be implied by law into these terms and conditions is excluded.
8. The Promoter may cancel the event where circumstances beyond the Promoter's reasonable control prevent the Promoter from holding the event. Should the Promoter cancel the Competition the Promoter will:
  1. advertise that the Promotion has been cancelled by placing a notice on the Promoter's website at [macarthursquare.com.au](http://macarthursquare.com.au);
  2. All entries are accepted entirely at the risk of the individual, and the Promoter excludes all warranties in connection with the ice rink to the extent permitted by law.
  3. The Promoter will not be liable for any loss or damage whatsoever which is suffered (including but not limited to indirect or consequential loss) or for any personal injury, loss or damage suffered or sustained (even caused by negligence) in connection entering the Ice Skate Rink, except for any liability which cannot be excluded by law.
